The following information provides a simple overview of what happens to people Data happens as soon as you visit our website.

Personal data are all data with which you can be personally identified.

We take the protection of your personal data very seriously and treat your personal data confidentially, or in accordance with the statutory data protection regulations as well of this data protection declaration.

We would like to point out that data transmission over the Internet (e.g. when communicating by e-mail) can have security gaps. A complete protection of the data against access by third parties is not possible.

The data processing on this website is carried out by the website operator. The responsible body is:

'Responsible body' means the natural or legal person who, alone or jointly with others, decides on the purpose and means of processing personal data (e.g. names, email addresses, etc.).

On the one hand, your data is collected when you communicate it to us. This can be, for example, data that you enter in a contact form.

If the data processing takes place on the basis of Art. 6 Paragraph 1 lit. e or f GDPR, you have the right at any time for reasons that arise from your special situation arise to object to the processing of your personal data; this also applies to profiling based on these provisions. The respective legal basis on which processing is based can be found in this data protection declaration.

If you object, we will no longer process your personal data, unless we can prove compelling reasons worthy of protection for the processing that your interests, Rights and freedoms predominate or the processing serves to assert, exercise or defend legal claims (objection according to Art. 21 Paragraph 1 GDPR).

If your personal data are processed for direct mail purposes, you have the right to at any time To object to the processing of personal data concerning you for the purpose of such advertising; this also applies to profiling insofar as it is associated with such direct advertising. As long as it is not yet clear whose interests prevail, you have the right to request that the processing of your personal data be restricted.

In the event of violations of the GDPR, the Affected parties have the right to lodge a complaint with a supervisory authority, in particular in the member state of their habitual residence, their place of work or the place of the alleged violation. You have the right to have data that we process automatically on the basis of your consent or in fulfillment of a contract handed over to you or to a third party in a common, machine-readable format. If you request the direct transfer of the data to another person responsible, this will only be done if it is technically feasible Send site operators, an SSL or. TLS encryption.
